Dear Sir/Madam,

This is to inform you that eligibility confirmation process (Phase I without penalty) for newly admitted UG, PG & Ph.D (Except B. Pharma/D. Pharma/MBBS/MD/MS/DM/MCh/Fellowship) students in the academic year 2023-24 is already over. However, it is noticed that few students have deficiencies and their eligibility application is currently under 'rejected' category and few students have not filled the eligibility form at all ('not submitted' category). Kindly note that the students who have submitted their online eligibility form and uploaded the documents but have not paid the eligibility fees through their eligibility login portal such students are also placed in 'Not submitted' category.

The (Phase II with penalty) of online eligibility portal is being activated with effect from December 20, 2023. An amount of Rs. 5,000/- per month penalty charges will be applicable to student whose eligibility application is currently under 'rejected' and 'Not submitted' categories.

Please inform to the concerned students (those who are yet to get PR Numbers) to do needful through their online eligibility login portal **under intimation to undersigned through email** (**registrar@mgmuhs.com**). Kindly note that the deficient / required documents need to be uploaded through student's login only. Non intimation through email regarding uploading of all documents OR submission of deficient documents through email attachment will not be considered and no request in this matter will be entertained by the University.

Kindly also note that some students even though have completed the eligibility process with status as **accepted** but have not paid the 1^{st} year tuition fees in full will not be assigned PRN unless they clear the 1^{st} year tuition fee in full.

Students who are unable to pay the eligibility fees through their online eligibility login portal need to inform to the undersigned with valid reason and only justifiable reason will be entertained.

Kindly note that eligibility process is an important step to assign PR Numbers to the students without which they are not registered with University as their eligibility is not ascertained in a time bound manner, failing which suitable action under MGMIHS rules and regulations will be taken including non-granting of their academic term OR non eligibility to appear in the University exam. This may please be informed to the concerned students at the earliest.

Dear Sir/Madam,

In continuation of the above subject & references, this is to inform you that scrutiny of the online submitted documents by students for eligibility process has been completed. Based on the status of the submitted documents by students, eligibility status have been categorised as follows:-

- A. Eligibility form and documents found to be correct (Status accepted).
- B. Documents incorrect / not relevant /not readable (Status rejected).
- C. Students who have not filled the online eligibility form.

Accepted or Rejected status is displayed in the student login zone on the website.

Therefore, following actions are being initiated:-

1. For rejected category students 'As per the deficiencies shown in the student's login, concerned student need to upload / re-upload the necessary documents in the stipulated time period from 21 November, 2023, 09.00 am to 25 November, 2023 up

to 05.00 pm. No additional penalty will be charged if re-submitted documents are found to be correct.

2. Students who have not submitted the online eligibility form can also complete the process from 21 November, 2023, 09.00 am to 25 November, 2023 up to 05.00 pm. No additional penalty will be charged from these students if submitted documents are found to be correct.

In the 1st week of December 2023, PR Numbers will be issued to those students who have completed the eligibility process successfully with 'Accepted Status' and also have paid tuition fees of 1st year in full.

Remaining students (Status rejected / not filled the online eligibility form) will not be issued PR Numbers untill they fulfill all needful requirements. Thus, with effect from December 01, 2023 academic term will not be granted to such students and also they will not be able to fill the University examination form due to lack of PR Numbers.

It is important to note that the documents which are to be submitted for eligibility were already known to the students / institutes as thay are all mandatory documents for admission process itself. The process of admission started in July/August 2023 thereby students were clearly having 4 to 5 months time to mobilise required documents untill now. Therefore, no excuses or reasoning will be entertained by University from such students after November 30, 2023 to receive the PR Numbers in 1st week of December 2023. All these students will get the PR Numbers only when they complete the eligibility process with applicable penalty.

All such students admitted in the academic year 2023-24 may be informed about above at the earliest to initiate necessary action from their side to avoid the academic inconvenience for which they will be solely responsible due to non-compliance.

If it is found that uploaded documents are not relevant / not readable / not correct, their eligibility application will be treated as 'not submitted' and it will also attract the applicable penalty after October 25, 2023. This condition is also valid for those who will be submitting the online form during extended period.
