This is to inform you that eligibility confirmation process is undergoing for newly admitted MBBS students in the academic year 2021-22. However, it is noticed that few students have deficiencies as shown in **Annexure 1** due to which their application is currently under **'rejected'** category.

Please inform all such students as shown in **annexure 1** to upload their required / deficient documents through their online eligibility login portal till July 15, 2022.

Kindly note that from July 16, 2022 onwards an amount of Rs. 10,000/- per month will be added as penalty charges.

Kindly note that eligibility process is an important step to assign PR Numbers to the students without which they are not registered with University as their eligibility is not ascertained in a time bound manner, failing which suitable action under MGMIHS rules and regulations will be taken including non-granting of their academic term OR non eligibility to appear in the University exam.
