Medical College & Hospital Kamotne, Navi Mumpai - 416209 THIS MOU is made at Panvel, Navi Mumbai and comes in effect from 1st day of January 2011 between YUSUF MEHERALLY CENTRE, TARA MANAGED BY YUSUF MEHERALLY CENTRE, TARA, DISTRICT PANVEL, (Registered as trust under BPT Act 1950: F -1072, Bombay, dated: 29.09.2000) having it's office at D-15 Ganesh Prasad, Naushir Bharucha Marg, Grant road west Mumbai 7), hereinafter referred as the FIRST PARTY

AND

M.G.M MEDICAL COLLEGE, KAMOTHE, NAVI-MUMBAI, hereinafter referred as Second party AND WHEREAS the FIRST PARTY is seized & possessed of and sufficiently entitled to the Rural Health Training centre (RHTC) at the land located in Tara Village under the Gram-Panchayat of Karnala, Mumbai Goa Highway, Dist. Raigad 410207 (hereinafter referred to as the said PREMISES which their exclusive possession is being in need of Medical Personnel including MBBS Qualified doctors & specialized doctors to manage the charitable Hospital has approached SECOND PARTY to manage their (RHTC).

AND WHEREAS SECOND party has agreed to manage their charitable. Hospital by way of providing the services of a qualified MBBS doctors at the said PREMISES (as specified hereunder) upon certain terms and conditions, which are accepted by the Parties who agree to reduce the agreed terms in writing and confirm the same.

NOW THIS AGREEAMENT WITNESSETH AS UNDER:-

- The FIRST PARTY hereby grants unto the SECOND PARTY their permission to use and occupy the said PREMISES to render primary care to the users of their (RHTC) and also the training of Medical Under graduates, Postgraduate students, Interns , Nurses and other paramedical staff in community health with effect from 1st day of January 2011 for a minimum period of 10 years.
- 2. The FIRST PARTY has no objection to the use of said premises as Rural Health & Training Centre (RHTC) of Department of Community Medicine, under administrative control of Dean of MGM Medical College, Kamothe, Navi Mumbai and also authorizes the said college to



reflect the same in documents submitted to the regulatory authorities such as MCI/Nursing and other Councils.

- The SECOND PARTY shall use the PREMISES for the specific purposes as outlined in para 1.
- 4. The FIRST PARTY will provide access to the SECOND PARTY to the existing infrastructure of the 30 bedded (RHTC) including OPD's, wards, laboratory, operation theater, x ray, Dental clinic, Physiotherapy, dressing room, injection room, Labor room & health education & domiciliary services etc. with the help of Village Health guides and also the covered area for purposes such as treatment of patients, holding health talks, health check-up camps, exhibitions and training.
- The FIRST PARTY will bear the cost of building maintenance, electricity, water taxes, safety and security concerns of buildings and staff and other incidental expenses.
- SECOND PARTY will provide the services of requisite staff for the RHTC during the working hours free of cost.
- The SECOND PARTY agrees to provide basic drugs for distribution among patients for the Primary Health Care.
- Both the parties mutually agree that to enable SECOND PARTY, to obtain necessary approval of the regulatory authority to reflect premises as RHTC. However the first Party will provide premises without any Rent to the Second Party.
- The FIRST PARTY shall ensure that the statuary requirements of licenses, approvals from the concerned Government and local Civic Authorities necessary for operating the treatment centre are obtained.
- 10. THE SECOND PARTY shall extend the services of Qualified MBBS doctors for 24 hours, Auxillary Mid Wives (ANM's) to provide Primary Care during the appointed hours.
