### MEMORANDUM OF UNDERSTANDING

This MOU signed on the Dt. 29/08/2015 by and between MGM Medical Center & Research Institute a company incorporated under the laws of India & having its registered office at N-6 Cideo, Aurangabad-431003 represented through its authorized signatory Chief Executive Officer (hereinafter referred to as "MGM's MCRI")

Road, Kalina, Mumbai-400098 represented through its authorized signatory Dr. Somnath Dutta (General Manager.-Mfg).

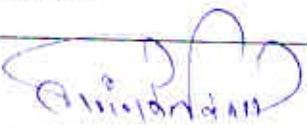

(Hereafter referred to as "Harman Finochem Ltd")

1. Hospitalization (IPD) for various diseases including Super-specialty Investigation, Procedure & treatment.



2. In case of an accident MLC will be registered at the time of admission & in all types of emergency hospitalisations, patient will get life saving medical treatment. The employer will issue referral letter by the authorized signatory of the company General Manager/HR Manager for the admission within 24 hrs.
3. Patient Report / Discharge Summary / Final Hospital bill will submitted to company and payment of the same bill will be made by Harman Finochem Ltd within 15 days after receiving the bill.
4. The hospital is empanelled for some Insurance Companies. In case of insured patient all formalities will be completed with active cooperation from the insured as well as the employer. Insurance coverage will be considered as per the authorization letter issued by the Insurance Company & Patient will be discharged only after the formalities laid down by the Insurance Company/ TPA are completed in writing. No exception will be possible for such patients.
5. Patient covered under Non-tie up Insurance Companies will have to pay hospital bill in cash & such claim should be filed by them directly with their respective Insurance Co.
6. In case of Patient requiring the discharge card/ Report he/ she can be asked to take Photocopies of the same.
7. Personal expenses like telephone, Food, Non payable expenses for insured etc will be recovered from the patient directly.
8. MOU may be terminated by either party serving one month prior notice in writing.
9. Incase of MLC cases patient will not get original document since they are retained in Hospital for medico legal purpose patient will get certified photo copy for the same.
