THIS MOU is made at Navi Mumbai and comes in effect from 1<sup>st</sup> November of 2015 BETWEEN Dr. Babasaheb Ambedkar Rugnalaya, run by the Khopoli Municipal Council having it's Office at Bajarpet, Khopoli, Here in after Referred as the **FIRST PARTY** 

**AND** 

MGM MEDICAL COLLEGE, KAMOTHE, Navi Mumbai hereinafter referred as SECOND PARTY

AND WHEREAS the FIRST PARTY is seized & Possessed of sufficiently entitled to the Municipal Hospital in Bajarpet, Khopoli hereinafter referred to as the said PREMISES which is in their **exclusive possession** being in need of Medical Personnel including doctor/doctors to manage the multi specialty outpatient services, laboratory services and Secondary & tertiary level health care to the users of their hospital has approached **SECOND PARTY** 

AND WHEREAS SECOND has agreed to manage their hospital by way of providing the services of a doctors at the said PREMISES (as specified hereunder) upon certain terms and conditions, which are accepted accepted by both the parties who agreed with the following terms is writing and confirm the same.

## NOW THIS AGREEMENT WITNESSETH AS UNDER :-

- 1. The first party hereby grant unto the SECOND PARTY their permission to use and occupy the said PREMISES to render health care to the users of khopoli hospital and also training of medical & paramedical students, postgraduate Residents, interns, Nurses and other paramedical staff in community health care and also rducate them the primary health Teaching with effect from 1<sup>st</sup> November 2015 for a period of minimum 5 years.
- 2. The SECOND PARTY shall use the PREMISES for the specific purposes as outlined in para 1.
- 3. The FIRST PARTY will provide all facility to SECOND PARTY to the existing infrastructure of 30 bedded hospital including OPDs, Wards, operation theatre, X-ray, Dressing room, injection room, labour room for the treatment of petients, also provide to hold health talks, health checkup camps, exhibitions and training and any other required space as suggested by the Regulatory bodied.
- 4. SECOND PARTY will provided the services of a qualified Medical Practitioners. Residents and Interns from different specialties such as General Medicine, Surgery, Community Medicine, Gynecology & Obstetrics, Pediatrics, Respiratory Medicine, Ophthalmology, E.N.T Dermatology, Nursing, Physiotherapy and any other specialty as and when required in future.
- 5. SECOND PARTY will also provided laboratory services at the said premises for which the FIRST PARTY will pay as per the cost effective Investigation charges list (No profit no lass basis) that is provided by the SECOND PARTY.
- SECOND PARTY will also provided outreach services to the vulnerable population and community health work like health education activities, health camps as planned by your concerned authorities.
- 7. The FIRST PARTY also agrees to provide exemption from the toll payments between Kamothe and Khopoli for vehicles that bring the Medical Personnel daily.
- 8. The FIRST PARTY will provided Tea, snacks and Lunch for the team of medical and non medical personnel who provided services on daily basis.
- 9. The FIRST PARTY will provided accommodation (well furnished minimum 3 rooms) in the said premises and Food (Breakfast, Lunch and Dinner) for Residential Doctors & Interns if doctor stay.
- 10. The FIRST PARTY has no objection to the use of said premises and the Data as Health, Training and Research center for all Residents including Department of Community Medicine, and also authorize the said college to reflect the same in documents submitted to the regulatory authorities such as MCI/ Nursing and other Councils.
- 11. In case the FIRST PARTY is eager to establish any other Specialty in their locality, the SECOND PARTY will extended the services
- 12. The FIRST PARTY also agrees to pay the transportation and other services rendered by the SECOND PARTY.
- 13. The FIRST PARTY shall ensure that the statuary requirements of licenses, approvals from the concerned Government and local Civil Authorities, necessary for operations and treatment of all kind of patients are obtained regularly.



- 14. THE SECOND PARTY shall extend the services of the Medical and Para Medical Staff to Provide Health care only during the appointed hours. Beneficiaries shall make their own arrangement for emergency care including provision of the ambulance for transportation. Apart from Primary Health Care, patient who needs Secondary and Tertiary care including emergency, will be teated at Secondary Party's Teaching Hospital at Kamothe/Kalamboli on concessional charges.
- 15. This agreement can be terminated by either party by giving 3 months notice without mentioning any reason for the termination.
- 16. All medico-legal cases will be dealth with Khopoli Doctor.
- 17. The FIRST PARTY will be providing all Medicines, Medical Instruments in OPD, IPD, OT, Labour room as per the requirement and the maintenance as per the requirement.
- 18. Any dispute relating to this agreement shall be subject to jurisdiction of courts at Raigad District only.
