



MEMORANDUM OF UNDERSTANDING FOR BLOOD & BLOOD COMPONENTS

This MOU (MEMORANDUM OF UNDERSTANDING FOR BLOOD & BLOOD COMPONENTS SUPPLY OF MGM MEDICAL COLLEGE & HOSPITAL BLOOD BANK) is prepared at Aurangabad on シム ロックス・18 ------ between Dattaji Bhale Blood Bank, C/o Dr Hedgewar Hospital campus, Aurangabad-431005 (Dattaji Bhale Blood Bank referred as Blood Bank or Dattaji Bhale Blood Bank for the sake of brevity) Represented by Dr.Manju Kulkarni, Medical Director, Dattaji Bhale Blood Bank.

AND

MGM Medical College & Hospital Blood Bank Aurangabad.

MGM Medical college & Hospital Blood Bank (situated 1.5 km from Dattaji Bhale Blood bank) is a centre providing services of blood processing & distribution of blood to those in need. MGM medical college & Hospital Blood Bank has principally agreed for the association as they will be benefited out of this arrangement without losing their independent identity.



MGM medical college & Hospital Blood Bank has approached Dattaji Bhale Blood Bank-Aurangabad for supply of blood & Blood components to which Dattaji Bhale Blood Bank-Aurangabad has agreed under the terms and conditions herein after below-

- 1. The quality of blood and blood components supplied by Dattaji Bhale blood Bank to the MGM medical college & Hospital Blood Bank shall adhere to the criteria in Annexure-1 and in accordance with the rules and regulations of drugs & cosmetics act of India as and when amended for supply of blood and blood components.
- 2. Dattaji Bhale Blood Bank shall be fully responsible for transfusion transmitted diseases testing of blood and blood components for HIV-I & II, HBsAg, HCV, Syphilis, Malaria and NAT. Dattaji Bhale Blood bank shall supply blood & blood components which are non-reactive of aforesaid disease.
- 3. Dattaji Bhale Blood Bank Aurangabad shall maintain the record of donors of all blood bags supplied to the MGM Medical College & Hospital Blood Bank minimum 5 years from the date of collection.
- 4.In case of Blood transfusion related reactions, Dattaji Bhale Blood Bank should provide all necessary Data of investigations reports of such components. Such information should be sent to MGM Hospital on official e-mail address of MGM Blood Bank (mgmbloodbank1993@gmail.com)
- 5. In lieu of blood bags supplied to the MGM Medical college & Hospital Blood Bank, the MGM medical College & Hospital Blood Bank shall pay the cost of blood bags as follows.

- 6. The above cost shall be valid for 1 year from the date of signing this agreement by both the parties.
- 7. Dattaji Bhale Blood bank during the term of this MOU, shall be obtain and maintain at its cost all licenses, registrations and authorizations as and when such are necessary to carry out supply as contemplated under this MOU. Dattaji Bhale Blood Bank-Aurangabad warrants that the collection, storage, processing, testing and dispatching blood & blood components owned or

processed by it shall be in compliance at all times during the period of supply, with all applicable statutory requirements in force at all times.

8.Dattaji Bhale Blood Bank shall make available all required regulatory approvals and necessary licenses, registrations and authorizations etc for audit and verification by MGM Medical College : & Hospital Blood Bank.

- 9. MGM Medical College & Hospital Blood Bank shall ask for the requisite quantity of blood bags as and when required.
- 10. the mode of payment shall be in the form of 'as par cheque' which shall be paid within 25 days from the date of blood bag issued unless otherwise specified. Same charges will be recovered from patient's relatives.

TERM & TERMINATION

This MOU shall be valid for one year from the date of signing by parties. In the event this MOU becomes unworkable, for any reasons, the parties to discuss in detail and arrive at fair, reasonable and mutually acceptable terms failing which parties shall agree to terminate this MOU. Any or all disputes related to this understanding, shall be settled amicably between the parties.
