iv)Your performance will be assessed periodically & if found satisfactory, the fellowship will be continued. Also you may have to serve an extended comprehensive rotation in cases you are not able to meet the expected exit competencies by the end of 12 months. The extended duration if any, will be deducted from the 3rd year Sub-speciality training period. Candidates who are able to meet the defined criteria early can be promoted to the next level of training and the months in question will be added to 3rd year sub-speciality training.
