The team offered these three alumni to lead for the registration, account opening and defining official protocol for proposed alumni association.



1. Definition of Terms used in bye laws:

The " President" shall be known as the secretary of "MGM's Alumni Association" MGM Institute of Health Sciences, Kamothe , Navi Mumbai. , Tal-Panvel, Dist-Raigad.

The "Secretary" shall be known as the secretary of "MGM's Alumni Association" MGM Institute of Health Sciences, Kamothe , Navi Mumbai. , Tal-Panvel, Dist-Raigad.

The Treasurer shall be known as the treasurer of "MGM's Alumni Association" MGM Institute of Health Sciences, Kamothe , Navi Mumbai. , Tal-Panvel, Dist-Raigad.

2. Area of Operation:

The area of operation will be limited to the all over in Maharashtra in the 1st phase and will be later expanded.

3. Accounting Year:

The accounting year shall be from 1st april or 31st March every year.

4. Membership:


The Meeting was called to inform all Head of Institution for Alumni Activity as per the direction of Hon'ble Medical Director, MGM Group of Hospital.






Minutes:

Item no 8- To finalize the logo and letter head design.


Resolution no 8- The member resolved to approve logo and letter head design, which was presented in the meeting (Annexure). The final copy will be ready before End of March 2019.

Dr Kiran Mali Thanked everyone and concluded the meeting with the request from everyone for active participation in the AA-MGMIHS.















