1. Definition of Terms used in bye laws:

The Sanstha shall be known as "Alumni Association of MGMIHS, Kamothe, Navi Mumbai,
Tal-Panvel, Dist-Raigad.

The "President" shall be known as the secretary of "Alumni Association of MGMIHS, Kamothe, Navi
Mumbai, Tal-Panvel, Dist-Raigad.

The "Secretary" shall be known as the secretary of "Alumni Association of MGMIHS, Kamothe, Navi
Mumbai, Tal-Panvel, Dist-Raigad.

The Treasurer shall be known as the treasurer of "Alumni Association of MGMIHS, Kamothe, Navi
Mumbai, Tal-Panvel, Dist-Raigad.

Area of Operation:

The area of operation will be limited to the all over in Maharashtra in the 1st phase and will be
later expanded.

2. Accounting Year:

The accounting year shall be from 1st april or 31st March every year.

3. Membership:

Member of the Association shall be only Ex-student of MGM's Medical College , Kamothe,
Panvel who become above 18years, who shall be willing to join the organization, shall be
considered and approved by the managing Committee within one month from the date of
receipt. The power to accept or reject the application shall vest with the managing Committee.

4. Types of Membership: There is following member of the society

- Life member** : Those who pay Rs. 10,000 as donation shall be called the "Life
Member" of the Association
- General Member** : Those who pay Rs.500/- as per years subscription shall be called
the " General Member " of the Association.


5. Termination of Membership:

Membership shall be discontinued on account of :


- Death or Insanity of the Member
- Resignation of the member if accepted
- Indulgence of the member in illegal matters considered against the social objectives of the
Society.

6. General Body Meeting: Powers and Functions.:

- The Annual General Body Meeting shall be called once every year by giving notice of 15
days before the date of the meeting.
- Discussion on the information if any given by the members of laying down of a resolution
will take place only if the members give a notice to the secretary 14days before the date of
meeting.
- Any resolution passed in the General Body Meeting cannot be altered or cancelled within a
period of two months.

Powers:

- a) To approve the expenses and the report of income and expenditure of the society.
- b) To appoint the auditor and decide on their remuneration by executive committee.
- c) For the fulfillment of the objectives change the policies or development programs accordingly.
- d) To appoint the committee members for Five years. The president A Secretary and Treasurer shall retain the right of reappointment.

7. **Notice of the General Body Meeting and Quorum:-** The notice of the general body meeting shall be given 15 days before the actual date of the meeting starting there in a day ,date, place and time. Minimum $3/5^{\text{th}}$ of the total members are required to be present for the meeting which shall be the quorum . However if there is no quorum due to the absence of members , the meeting shall be adjourned for half an hour and shall commence , the meeting shall be adjourned for half an hour and shall commence its business thereafter on the same day and at same place and which the same agenda and the members present shall from the quorum.

8. **Extraordinary General Body Meeting and its functions:**

The extra ordinary general body meeting can be called if and only if minimum $3/5^{\text{th}}$ members of the society give a written one month and other rules shall be as per general body meeting. The meeting can be called by giving a prior notice of 15 days of the date of the meeting for discussion of the almost urgent and important matters. Minimum $3/5^{\text{th}}$ of the total members are required to be present for the meeting. In case of vacancy of the post caused in managing committee within a period of two months of election , an executive body meeting shall be called for filling up the post. Any change or alteration in the program shall be discussed and the option of the members given in the Extra-Ordinary general Body Meeting shall be followed accordingly.

9. **Managing committee and its set up:**

Managing committee shall be at followed members and for administrative purpose its set up will be as under:- 1) President 2) Vice President-1 3) Gen. Secretary -1 4) Treasurer-1 & others are committee members. Total shall be 7 and maximum 17 members. First managing committee will be of 15 members.

10. **Team of Managing committee and Procedure of electing office Members.:**

- a) The Managing committee shall be elected by informant & Approved method in General Body meeting .
- b) The managing committee shall be elected after every five years and shall consist of President. Vice President, secretary, treasurer and other executive members.
- c) The postponement of election shall be decided in the General Body Meeting
- d) For conducting the elections, the members shall have to appoint an election officer who will look after the procedure of the election and have to control over the election
- e) The duty of the election officer shall be over only after announcing the name of the elected members.
- f) The election officer shall have the authority to reject the application of candidate for the reasons of non payment of fees misbehavior etc.

11. **Office bearers of Managing Committee and their Duties:**

- A) **President:** i) To call the meeting of the society. ii) to grant permission to discuss other topics which are other than regular programs of the society. iii) the final Decision shall be given by the chairman. In case of equal votes the power of granting permission to the regulation passed by the members shall also remain in the hands of the president. Iv) To look after the overall working of the society vi) To give final decision on the complaints and problems received from the members.

- B) **Vice President :** In absence of president he will do the presidents duty. He will help to the President in daily work.

- C) **Secretary :-** the secretary shall try his best and retain the goodwill of the society. the secretary shall : 1) Call and decide on the program of the meeting by the approval of the president. 2) Write the minutes of the meeting. 3) look after and control the work of the society. 4) Prepare the Balance sheet, Profit and loss account and present it before the members. 5) Call urgent meeting with the prior permission of the president. 6) Solve queries. 7) In case of misbehavior of members take appropriate action by bringing it before the managing committee. 8) Look after the affairs and the correspondence of the society. 9) look after the work of the staff of the society , take appropriate decision at that moment and take approval to it later in the next.
- D) **Treasurer:** - 1) Keep the accounts of the society. 2) Operate Bank transactions with the joint signature of either the president or secretary. 3) Look after the account of the society and deposit of funds in bank. 4) Completion of the work assigned by the Managing Committee.
- E) **Executive committee members:** They shall help in arranging functions and doing day to day routine work to all other managing committee member. They shall perform all the responsibility entrusted to them.


12. **Meeting of the Managing Committee and Meeting on Resolution:** a) The committee shall meet once in 3 months . b) If any member or pass a resolution, he should give a written notice three days prior to the date of meeting. C) In case of work of utmost importance a meeting on requisition can be called anytime so that proper decision and action can be taken on time. D) Requisition meeting will have equal full powers like managing committee meeting.


13. **Notice to the Managing Committee and Quorum:** Members shall be given a notice of at least 7 days prior to the date of managing committee meeting 1/5th members shall form quorum of Managing committee meeting.


14. **Rules for election of Managing Committee:-** 1) Any members of the society who desire to work in agreement with aims and objects can contest the election for managing committee. 2) Election will be held by show of loud / secret ballot papers. 3) When there will be equal votes of both the sides President has his casting vote in addition his own vote. 4) At least he showed complete five years of membership.

15. **Appointment in vacant post of member of executive committee:** If any vacancy is caused in managing committee executive in authorized to cooperate executive committee member in vacant post and his period will be over along with the existing Managing committee.

16. **Powers and duties of the Managing Committee:** a) The affairs of the society shall be looked after by the managing committee. b) The managing committee shall finalize the list of regular members. c) Discussion on the information if any given by a member or on laying down of a resolution will take place only if the member given a notice to the secretary three days prior to the date of meeting. d) The managing committee shall look after the financial affairs of the society and manage its fixed as well as current assets and also provide receipts for the consideration and donations received e) To approve receipts and payments of the society and also prepare the budget and report of the preceding year with the help of the Treasurer. f) The managing committee can make a proposal for the amendment of the constitution of the society. g) The managing committee can appoint staff for society ,decide on terms and conditions of committee has a right to take appropriate to the work, salaries, perks and promotion. If a worker misbehaves the managing committee has a right to take appropriate to the worker to the worker of being heard and on consideration there after the managing committee shall take the final decision. h) The managing committee shall arrange the programs which have been altered or introduced by the general body meetings. I) The managing committee shall work for the fulfillment of the objectives of the society and shall provide the necessary finance and requirement. J) For fulfillment of objective as the managing committee shall communicate with the other societies and try to have relations with these societies. K) The managing committee may publish books, pamphlets and periodicals to reach the members of the society and collect funds for the programs of the society. l) The managing committee shall prepare the Sub-classes of society. m) The managing committee shall arrange the programs and shall collect funds for the same.

17. Sources of Income of society: -

Income sources at the society will be as under:-

1. Subscription from all the members.
2. Grants , Subsidies from Governments.
3. Donations from donors and well wishers.
4. Donation will be accepted in form of cash and kind cheques.
5. Interest on the bank account fixed deposits and through other Investments.

18. Objectives based provision for expenditure:-

The expenditure shall be based on the decision taken by the Managing Committee from time to time. 100% amount will be spent for the same purpose object amount is collected after balance about will be spent for charitable 50%, Educational 50%.

19. Provision for loans and deposits:-

For the financial development and programs the Managing Committee can take loans as well as accept deposits with the prior permission of the charity commissioners Maharashtra State , Mumbai.

- 20. Provision regarding purchase and sale of immovable Property:-** The managing Committee shall look after the Management of the fixed and current assets. 21. Operation of Bank account and other financial matters:-

22. Maintenance of register of members:

25. Dissolution of the society:-

If the Society is to be dissolved for any reason what so ever the fixed and the current assets shall be donated to any other society, working with the same objectives. The general body meeting shall take proper decision on this matter. The decision shall be taken according to sec 13 & 14 of the societies Registration Act 1860.

FINDINGS AND ORDER

- (11) What are the particulars of the encumbrances, if any, on the trust property?
- (12) What are the particulars of the scheme, if any, relating to the trust?
- (13) What are the particulars of title deeds pertaining to the trust property and the names of trustees in possession thereof?
- (14) Whether the particulars stated in the application are correct?
- (15) What is the name of the Trust?

Reasons for Findings
