Decision - The members discussed and unanimously agreed on observational posting for first year M.Sc. Nursing students to clinical laboratories. It was suggested to consider laboratory experience in the subjects-Advanced Nursing Practice and Clinical Nursing Speciality-I in First year M.Sc. Nursing course.

The observational posting in clinical laboratories like Biochemistry, Microbiology and Genetics was suggested for comprehensive understanding of processing of samples. This experience will aid in application of knowledge in clinical practice and understanding of nursing responsibilities in collection, storage and dispatch of samples including interpretation of results as well as patient teaching.

Total suggested hours:

Genetics - 10 hours (to be taken from unit XI - Computer applications)

Biochemistry - 10 hours (students can be sent from clinical posting)

Microbiology - 10 hours (students can be sent from clinical posting)

Blood Bank - 5 hours (students can be sent from clinical posting)

Pharmacovigilance - 5 hours (During clinical posting in ward setting)

It was decided that details of activities for aforesaid duration posting will be submitted by Chairman, BOS [Annexure - 52]

- 3) To discuss the strategies for effective implementation of national policy on occupational safety, occupational health and working environment in.
 - Content in the curriculum
 - Research Priorities.
 - Management training

Decision - It was resolved that the topics on Occupational safety and on Occupational health is already present in the existing curriculum however certain occupational hazards like Tuberculosis, HIV etc. need to be incorporated in the curriculum including preventive strategies for the employees.

Members also resolved that UG and PG students can conduct some descriptive studies on employee satisfaction, occupational hazards among various categories of health care workers and develop certain protocols in each unit.

4) Moderation of question papers

Discussion - The question papers in Anatomy, Physiology, Biochemistry and Microbiology are being set up by the nursing experts. Moderation of these subjects to be done by the nursing experts instead of subject experts as proposed in BOS, for better evaluation of the students during the University examinations.

Decision – It was resolved that as the theory papers are set and moderated by qualified Examiners and Moderators, no further process is required.

5) Academic Calendar of B.Sc. Nursing & M.Sc. Nursing 2016-17.

Resolution - It was resolved to accept Academic Calendar for B.Sc. Nursing [Annexuré-53] & M.Sc. Nursing [Annexure-54] for 2016-17.

Rest of the items were not considered (already in practice/out of purview/lack of detail information/rejected by BOS itself/only for information of members)

Item No. 4: To review the research activities in last 6 months (i.e. October -2015 to March -2016).

Dr. C. P. Puri presented the Research activities during last 6 months (i.e. October -2015 to March -2016) of MGM Institute before the House. He further informed the house that a link has been provided, on trial basis, on the University website for gathering all data in to the "Central Resource Centre".

Resolution -

- (a) It was decided that one paper per faculty per year has to be published. Therefore 300 teachers + 300 PG students must published together 600 papers per year.
- **(b)** MGM Journal should be indexed in the Copernicus. Therefore all attempts in this regard have to be expedited.
- (c) All efforts should be made to enhance the Extramural fundings.

Resolution: All faculty members were request to give their valuable feedback on this issue.

Item No. 8: Methodology & criteria for the assessment of learning levels to define slow performers & advance learners.

Resolution: It was resolved to approve the methodology & criteria for the assessment of learning levels to define slow performers & advance learners [Annexure-55]. It is also resolved that at individual constituent unit level, modifications are allowed as per regulatory bodies norms.
