Item No 1:

To confirm the minutes of last meeting

Resolution No 1:

Item No 2:

Affixing QR code / Bar coding on Answer books of all University examinations of MGMIHS

Resolution No: 2

A presentation to the effect was given by the Director Extrax mobility all the pros and cons of the system were discussed in details and doubts sorted out wherever ever existed.

The members unanimously resolved to adopt encrypting QR codes on examination answer booklets along with OMR marking /evaluation process. The Registrar was requested to complete the codal formalities to operationalise the same at the earliest.

Direct feeding of marks immediately after evaluation of written papers, viva-voce and practicals at CAP centre itself, by respective conveners in presence of all examiners

Resolution No: 3

The members broadly accepted feeding of marks by evaluators at the CAP centre itself. However, with implementation with the QR/OMR based examination book as well as the upcoming EPR system, this process would be integrated with each automatically for speedy implementation.

Item No 4:
