#### Item No. 1: Academic matters:

1.1 To start new job/skill oriented programmes

**Decision:** Resolved to start job/skill oriented programmes in view of increasing professional need of society.

ATR: MGM School of Biomedical Sciences is running various B.Sc. & M.Sc. programmes in allied health science (Paramedical Sciences) which are job/skill oriented. (Page No. 06 & 07)

Recently Bachelors in Prosthetics and Orthotics (BPO) programme has been started to fulfill the need in the area of rehabilitation.

1.2 To start fellowship programmes

Decision: Resolved to start fellowship courses under MGMIHS from academic year 2018-2019.

ATR: Various fellowship courses were approved from academic year 2018-2019 at both the campuses. (Page No 108)

1.3 To start new PG programmes

**Decision:** Resolved to start M.Ch. Neurosurgery and DM Neurology will be started at MGM Medical College, <u>Navi Mumbai/Aurangabad</u> after permission from MCI.

ATR: Proposals to start M.Ch. and DM courses at Navi Mumbai/Aurangabad have been sent to MCI. MS (Trauma) is also planned to start at MGM Medical College, Navi Mumbai.

1.4 To start Naturopathy / Ayurvedic programmes

**Decision:** Resolved to start Naturopathy / Ayurvedic programmes (BNYS) at Aurangabad Campus under MGMIHS and send the proposal for same to Central Council for Research in Yoga and Naturopathy (CCRYN).

ATR: Proposal to start Naturopathy / Ayurvedic programmes (BNYS) at Aurangabad Campus under MGMIHS is under consideration of Health Department, Govt. of Maharashtra.

## Item No. 2: Administrative matters:

2.1 To adopt office automation (ERP) to create environment friendly paperless work system
