DNA is one of the most powerful biomarker in molecular biology and analyzed for various purposes ranging from screening of infectious diseases, study of basic functions of cells and abnormalities associated with them, mutational analysis, study of polymorphism associates with genes and analyzed for forensic studies for identification of victims etc. After the discovery of structure of DNA in 1953 various molecular biology techniques have evolved for analysis of DNA which mainly includes electrophoresis techniques, southern blotting technique, PCR Technique, DNA sequencing technologies.

The samples used in standard diagnostic tests typically contain only tiny amounts of a disease's related nucleic acids. To assist optical detection, clinicians amplify the number of nucleic acids making them easier to find with the fluorescent dyes. Both the amplification and the optical detection steps have in the past required costly and bulky equipment, largely limiting their use to laboratories.

In order to screen the infectious diseases at rural setups in countries like India, there is need to develop portable low cost, battery operated systems to sustain the detection technologies at primary healthcare centers. This study addresses development of low cost portable DNA detection system which can be operated at primary healthcare centers by paramedical persons for primary screening of infectious diseases in order to speed up the overall process of diagnosis and treatment.

The basic principle of detection will be target specific probes will be utilized to amplify the targeted nucleic acids by conventional thermal cyclers and then the signal from the amplified nucleic acids will be detected on custom built detection system.

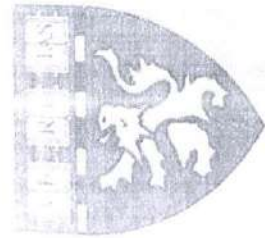




