- Both the MGM colleges at Kamothe and Kalomboli are authorized for disposal of biomedical wastes on the premises to Mumbai Waste Management Limited (MWML), Taloja.


- This facility is registered under Maharashtra Pollution control board for collection, transportation, treatment and disposal of BMW generated.

The Green audit of the campus was carried out on 7.4.15. The following observations were made regarding the green practices of the University

Waste Management

- **Solid waste management**

The biodegradable waste is treated in the compost plant capacity of 486 cubic feet available at the Navi Mumbai campus.

- **Liquid waste management**

Sewage Treatment Plant of a daily capacity of 400 cubic meters daily is functional for management of liquid waste.

The following observations were noted

➤ ***The Institute is committed for:***

- Polythene/ plastic bag restricted zone.
- Tobacco and Alcohol-Free Zone
- No Smoking zones

➤ ***Energy conservation and Use of renewable energy:***

- Solar heaters are installed for water heating for hospital, college, hostel use.
- The buildings are constructed in such a way that ample natural light and ventilation is made available. This results into conservation of electricity.
- Special awareness programmes are carried out for the stakeholders to conserve energy.
- Following upgrades implemented to use energy efficient appliances
- Tube lights 36/40 watts are preferred over 60 /100 watts electricity bulbs for artificial illumination
- Use of 3star /4 star rating low energy consumption equipment's/machinery.
- Use of LCD/ LED (less energy consumption) monitors

- Reminder/Placards (Switch off artificial lightening and unplug electrical and electronic devices) in various departments, lecture halls and corridors.
- Plantation of trees has been increased to sequester Carbon dioxide emitted in the atmosphere.

➤ ***Water harvesting:***

- Water harvesting is installed in every building of the campus.
- Sewage treatment plant is installed for treatment of waste water and this treated water is reused for gardening and plantation purpose at both the campus.
- Small pond is made available and its water is utilized for gardening purpose.

➤ ***Efforts for Carbon neutrality:***

- Burning of laboratory waste and other waste materials has been banned and biological waste is being sent out through contracting the same to an authorized biological waste disposal agency

➤ **Hazardous waste management:**




Green Audit Committee Report (2016-2017)

The green audit of the MGM Medical College, Navi Mumbai campus was carried out in 21.5. 2017. The purpose of the audit was to ensure that the eco-friendly practices are being followed in the campus. The specific objectives of the audit were to evaluate the adequacy of Practices related to Environment Sustainability and degree to which the Departments comply to applicable requirements.

Green audit methodology included physical inspection of the campus, review of the relevant documentation, and interviews.

Following were the observations during the green audit

1. Maximize the proportion of waste that is recycled

- Solid waste is collected in various forms as per standard protocols into biodegradable and non-biodegradable waste.
- The biodegradable waste along with biomass available from the campus is taken for composting. All organic waste, green waste and un-recycled cardboard produced in or collected from kitchens, gardens, offices and rooms.
- Provide sufficient, accessible and well-publicized collection points for recyclable waste, with responsibility for recycling clearly allocated

- Biomedical waste is collected in colour coded bags and disposed of in accordance with CIDCO standards. MGM Medical College, Navi Mumbai is registered for disposal of biomedical waste(MWM-BMW PAN-1069).
- At the MGM Navi Mumbai campus, segregated E-waste is shifted to the premises of disposed of MGM within the campus by “Eco Recycling Limited” company in accordance with the MOU with the Dental College.
- Recycle or safely dispose of white goods, computers and electrical appliances.
- Promote reuse of items and waste recycling among staff, students and conference guests through training, posters and incentives
- Yes, the college dispose all waste, whether solid or otherwise, in a scientific manner and ensure that it is not released directly to the environment.

2. Reduces energy consumption

- College has solar heaters installed in the student hostels. Initiatives for introduction of Solar panels is in process
- The College is installing LED bulbs for energy conservation
- Misuse of electricity is controlled by turning off the appliances when not required.
- Ensures that all electronic and electrical equipment's, such as computers, are switched off when not in use, and is generally configured in power saving mode when such option is available

3. Minimize the use of unsustainable transport

- Pooling of cars is encouraged
- Use of Public transport by a large proportion of faculty and students. To facilitate the process, pick and drop facility to nearby railway stations provided by the college.

4. Minimize consumption of water.

- At the Navi Mumbai campus, Sewage Treatment Plant of a daily capacity of 400 cubic meters daily is available for management of liquid waste.

- Regular checking and maintenance of pipelines are done to control water wastage.
- Appliances installed which reduce water consumption
- Installed Water recycling mechanism, such as rain water harvesting system. Rain water harvesting provides 1.5 lac litres of the total water requirement of 5.5 lac litres per day.

5. Green Practices

- A Nursery available in the campus
- College already has a well-maintained garden.
- Encourage the faculties and students to plant trees in the garden.
- Plantation drives are carried out by students and faculty
- Reviews periodically the list of trees planted in the garden periodically

6. Environmental awareness

- Seminars and awareness programmes are conducted periodically on Nature and natural resources, wildlife for the conservation of Biodiversity.
- Environment day is celebrated
- Environmental Health Module (45 hrs) has been incorporated in the UG Curriculum to promote eco-friendly practices

7. Paperless Office

- The University Administration has installed ERP Software which has had a major impact in reducing the use of paper.

Referring to above subject, green audit report of the campus as follows,

1. Water management

- Water resources: - Potable water is provided by CIDCO Ltd. - 4,50,000 Ltr/day. Approx. CIDCO supplied water is used for drinking purpose in campus also use for canteen, various testing lab.
- Recycled water: - Sewage water is treated & reused for gardening, flushing in toilet, STP Capacity is 4,00,000 Ltr/day.
- Storm water storage- This storm at low level area where pond is created. It's capacity about 2.75 Cr. Ltrs. Which is use to maintain green area & play ground & other cleaning work.

2. Energy use & Conservation: -

- Energy source :- Electricity supply is getting from MSEDCCL. distributed in all over in campus. Sanction Demand 1400 KVA.
- Conservation:- Energy conservation we use solar water heater in UG & PG hostel. We use LED light in campus we have 600 + LED fittings are installed in campus. (Annexure "A")
- Solar Energy :- We will install roof top solar power plant in our campus (Annexure "B"). Solar power capacity is around 1 MVA. Survey for solar plant is completed.
- Major Energy consuming Equipment:- Hospital building having major energy consuming Equipments like HVAC, CT Scan, MRI. Etc.
- Power saving methods:- we use cyclic timer in various place. Also we install LED light in new electrical work.


3. Waste management :-


- General garbage:- Some waste is disposed through CIDCO service vehicle. Biological waste is given to authorized license agency by CIDCO.

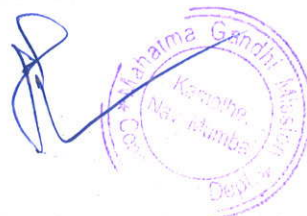


