Resolution No. 4.4.i of BOM-61/2020: Resolved to include Director (Research) as a member of MGMIHS Planning & Monitoring Board. It was further resolved that Director (Research) should explore suitable DST/ICMR/DBT projects for all PG/Ph.D. Students and faculty.

Resolution No. 6.1 of BOM-61/2020: It is unanimously resolved to approve the Action Taken Report on the resolutions of FC-44/2019 dated 11th November 2019 with the following decisions:
