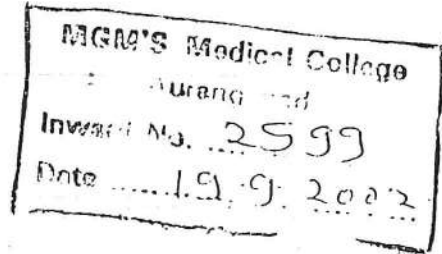

2 Principles:-

**MGM School of Physiotherapy & Aastha Foundation Aurangabad.**

Agrees to the following.

- 1 To identify & develop mutually beneficial educational opportunities, progresses & wish to enter in this MOU for the development of physiotherapy students, faculties, sports scientist, coaches and athletes.
- 2 To explore research opportunities that may develop from the alignment of **MGM School of Physiotherapy & Aastha Foundation Aurangabad.**
- 3 Any activity carried out within the broad framework of this MOU shall be subject to mutual consent of the both parties.
- 4 Both the parties to emphasize upon common objectives & goals for promotion & development of sports activities & sports persons.
- 5 As a service provider, MGM School of Physiotherapy will not accept any kind of honorarium/remuneration from **Aastha Foundation Aurangabad.**
- 6 Basic equipments required for setting up the physiotherapy clinic setup at old age home will be provided by MGM School Of Physiotherapy.
- 7 All other facilities required at centre will be provided by Aastha foundation Aurangabad

3 **Renewal, Amendment & Termination:-**
