 - ✓ Medical fitness Certificate from registered Medical Practitioner (No fix format for it)
 - ✓ Caste Certificate/ Cast Validity Certificate/ (if applicable)
 - ✓ Non-Creamy layer certificate (For ST, SC & OBC candidate)
 - ✓ 3 Passport size photographs
 - ✓ Copy of gazette officer in case of name change of candidate
- 5. The candidate has to pay Annual Tuition Fees of first year Ph.D. programme through their online application form login portal immediately after the generating provisional admission letter.

- 6. The candidate should pay the Tuition Fees of first year in the form of Demand Draft only. No other mode of payment will be accepted. Demand Draft must be made in favor of "MGM Institute of Health Sciences" payable at Mumbai. Multiple DD's in different denominations are allowed in case a single DD for the 1st Year tuition fee is not feasible.
- 7. After due scrutiny of the original documents and payment confirmation of 1st year tuition fees, provisional admission letter will be issued to the student on the day of counseling. Student is expected to act as per directions mentioned on the provisional admission letter. Without payment of 1st year tuition fees in full, admission will not be granted and such student will not have any claim for admission.
- 8. Students himself/ herself must be present to the counseling venue. No proxy will be allowed in any circumstances.
- **9.** All provisionally admitted candidates need to report to the college immediately for completion of the admission formalities.
- **10.** Candidates are requested to strictly adhere to counseling schedule which is put up on University website.
