As per the Hon'ble Supreme Court of India, Directorate General of Health Services, (DGHS) guidelines, admission counseling for all D.M./M.Ch. seats of the Deemed Universities will be done by DGHS/MCC. Therefore the process of D.M./M.Ch. Admission for constituent Medical Colleges of MGM Institute of Health Sciences, Navi Mumbai will be as follows:

- 1. All NEET SS-2023 qualified candidates who are interested in getting admission at following constituent Medical Colleges need to select these colleges as their choice on **MCC portal** of DGHS.

- 1. Selected candidates in each counseling round need to report to Deans of respective Medical Colleges of MGMIHS as per the instruction of DGHS/MCC during defined reporting period only. It is further advised to report in the earlier part of reporting period to avoid last minute unforeseen issues. Reporting time is 9.00 am to 5.00 pm on all days (including Saturday, Sunday and Public holiday) during reporting period. The process of reporting and admission may take time therefore, candidates need to plan their travel and stay accordingly.
- 2. At the time of reporting, candidates must submit:

Students can pay in multiple DD's with amount totaling to the total fees. Kindly note that the annual tuition fees will be same for entire duration of DM/M.Ch. course (3 year).

- Full tuition fee of 1st year has to be paid at the time of admission. No Installment facility is permitted
- Annual Tuition fees is same for Recognized and Permitted seat. Allotment of recognized seat will be based on NEET Merit at College level.
- If fees, is to be paid by RTGS, student must report first to the respective medical college and submit the documents for verification. After verification of documents, he/she can pay the fees by RTGS. Kindly note that RTGS mode to be avoided during last 2 days of reporting period because unforeseen banking delay may lead to non-receipt of tuition fees. Thus, admission may not be granted in such a case.
- All the documents in original OR through 'DigiLocker' as per check list attached with this notification (Annexure -01) with two sets of self-attested photocopies.
- Without original documents, demand drafts of Tuitions Fees and completed bond documents candidate will be considered as 'Non Reported' even if he/she is allotted for a particular round and has visited the medical college.
- Students himself/herself must be present to the respective Medical College at the time of reporting. **No proxy will be allowed in any circumstances.** Candidate must join duties as per the instructions of respective Dean's office/MCC/NMC.
- All candidates are informed that if the term (college) has already started they need to join the college immediately after completing admission formalities.
- Only physical reporting is permitted. No online reporting is allowed.

University Eligibility fees need to be paid after joining the course **(Annexure- 02)** for which separate notification will be issued later

Other fees (Hostel fees, Mess fees, Library fees, Gymkhana fees, Security deposit and miscellaneous charges) need to be paid at the college level. For further information regarding other fees, bond etc., click on the below constituent Medical college website OR write an email:-

- 4. Other fees will be required to be paid only if candidate has decided to retain the seat in the allotted college.
- 5. All original documents will be returned to the student after verification and granting of eligibility by the University at a later stage.
- 6. Candidates are requested to strictly adhere to counseling schedule/scheme put up on www.mcc.nic.in
- 7. 'Seat surrender' (For any valid reason) by any student as per MCC guidelines after securing admission will be done after deduction of Rs. 10,000/- as administrative charges from the paid tuition fees and rest amount of 1st year tuition fees will be refunded back to the designated bank account of student / parent within 3 bank working days excluding the day of receipt of seat surrender request at the medical college office.
- 8. One year compulsory bond to be submitted in prescribed format at the time of reporting itself. Format of the Bond is enclosed as (Annexure 03) (Candidates opting for upgradation need not submit the bond document at the time of reporting).
- 9. The registration charges if any paid to MCC is not part of tuition fees. Any clarification therefore, may be held with MCC only.
- 10. Kindly be aware of the fake websites and the old notifications available through google search. Only the latest notifications available on official website of the University / Medical College need to be followed. Further refresh the pages before viewing the official website.

WHEREAS

- 1. The Party of the first part is the Mahatma Gandhi Missions Institute of Health Sciences, a deemed to be University registered under the University Grants Commission Act and established by the Mahatma Gandhi Mission Trust (MGM Trust), registered Public Charitable Trust. The Mahatma Gandhi Missions Institute of Health Sciences has 2 constituents Medical Colleges in Navi Mumbai and in Aurangabad.
- 2. The Party of the second part is a student who has taken admission and enrolled/ is desirous of enrolling in the course of (Degree) DM/MCh offered by the Colleges/Institutes, which are run and administered by the Party of the First part.
- 3. The party of second part on completion of the course of (Degree) DM/MCh will be qualified person to be employed to the post of Senior Resident/Tutor with the party of first part. The Party of the second part has agreed and undertaken to join the employment of the party of first part as a Senior Resident/Tutor and work with the party of the first part for a period of 1 year.
- 4. The party of the second part has also agreed to execute a Bond, Indemnity and Undertaking in relation to the employment etc. The party of the second part acknowledges, admits and undertakes that after the completion of the course of (Degree) DM/MCh, the party of the second part will join and continue to work with the party of the first part for a period of 1 year. The party of the second part will be paid salary.
- 6. The parties have now mutually decided to reduce the same in writing on the following terms and conditions:-

NOW IT IS AGREED BETWEEN. THE PARTIES HERETO AS FOLLOWS:

- (i) The party of the second part agrees to work with the party of the first part as a Senior Resident/Tutor at the -----run and administered by the party of the first part at a pre defined monthly salary/stipend based on the MCI/Government norms.
- (ii) The party of the second part agrees, undertakes and is bound by the agreement, bond and undertaking to work for a total period of 1 year from the date the party of second part assumes charge of the said post. The said period may be extended for a further period from time to time as may be agreed upon. The party of the second part and the sureties have has also executed the required bond, indemnity and undertaking.
- (iii) The party of the first part shall pay to the party of the second part a pre defined monthly salary/stipend based on the MCI/Government norms.
- (iv) The party of the first part will, as far as possible provide a suitable residential accommodation to the part of the second part free of cost.
- (v) The Party of the Second Part agrees and admits that the rural posting for specified duration will be compulsory. The place of posting will be purely at the discretion of the Dean/Management.
- (vii) The party of the second part will be entitled to leave as per the norms of MGMIHS.
- (viii) The party of the second part will devote the whole office or working time and shall work faithfully, sincerely, diligently and efficiently and to the best of her ability and make her best efforts to use her knowledge and skill in providing the best medical services and medical care to the patients.

- (ix) The party of the second part will diligently undertake and complete the administrative work related to the patients assigned to her/him. The party of second part will not divulge or disclose to anybody any medical case papers, examinations details, reports of any of the patients.
- (x) If the party of the second part resigns from service and terminates this agreement before the expiration of the said period of 1 year, she/he will be liable to pay to the party of the first part a sum of Rs 25,00,000/ (Rupees Twenty Five Lacs only) as per the agreement, bond indemnity and undertaking.
- (xi) The party of the second part will not remain absent from the work without a prior intimation and without obtaining prior written permission of the Administrator of the hospital or in his absence of any other Director of the Hospital.
- 7. All disputes or difference pertaining to the subject matter of the this agreement or in respect of the employment of the party of the second part shall be referred to Arbitration.
- 8. This agreement is executed in duplicate and one copy each will remain with the parties.
