- 1. Title of the Fellowship: MGM Interventional Radiology fellowship
- 2. Duration of the Fellowship: 1 Year (12 Month)
- 3. **Commencement (2batches):** A) 1<sup>ST</sup> June, 2018 starting the fellowship b) 1<sup>st</sup> December, 2018-we shall take fellows subject to the review at the end of three months after the commencement of the first batch.
- 4. **Objectives of the fellowship:** While the emphasis will be primarily on vascular intervention, the fellows will also get exposure to a wide spectrum of guided interventions inclusive of all modalities
- 5. Eligibility criteria for admission: post-graduate in radio-diagnosis and imaging (MD/DMRE/DMRD/DNB/FRCR or equivalent qualification)
- 6. Intake capacity in each batch: 2, to begin with, to be increased later, subject to revision based on the patient inflow and work-load, review at the end of three months after the commencement of the first batch.
- 7. Admission / selection process/ procedure: As decided by MGM University.
- 8. Fees: 10 Lac per fellow per year to begin with
- 9. Course content: 1. Daily log book maintenance with details of procedures 2. patient follow-up and management 3. Assistance in all intervention cases, handson as assistant and depending on the competence, as primary operator under supervision. 4. exposure to in-house and special procedures at other centres 5. one national/international paper presentation/publication or audit report each in the year
- 10. **Teaching scheme**: On the job training mostly being a practical fellowship 2 theory sessions per month.
- 11. Complete curriculum of the course: Attached
- 12. Text book & reference books: List attached
- 13. Scheme of examination (in detail)(pattern of exam / passing criteria award of Fellowship): cumulative assessment with credit scores submitted every Month and a theory exam at the end of the course.
- 14. Infrastructure required for conducting the course & its availability in the college / hospital-Cath lab existing, two technicians on rotational duty, 'on-shelf' basic hardware/life saving emergency kit/stock in pharmacy-basic investment/ space for consultancy/patient examination room/arrangement/vendor management is responsibility of the hospital, otherwise consumables to be charged to the patient / procured through MJPJAY.
